Because they are dubious and in general do not justify their scientific status. Many scholars consider parapsychology a pseudoscience. Carl Sagan noted that there are three directions in parapsychology that have some experimental validation and are "worth serious study" because they "can be real": human mental effects on random number generators (Psychokinesis); experiments in sensory deprivation for Extrasensory Perception; phenomena in which children sometimes tell details of past lives, which turn out to be accurate when examined, they cannot.
